Context

The growing use of artificial intelligence involves an increase in digital hardware infrastructures [Morand et al., 2024; de Vries, 2023], particularly data centers that host both storage platforms and high-performance computing infrastructures. Numerous reports highlight the rising energy consumption of these data centers (e.g., the IEA report [IEA, 2024]) and offer consumption projections for the coming years. These estimates depend on various assumptions (e.g., the number of data centers, the quantity of GPUs sold, the efficiency of data centers, etc.), the scope considered (e.g., only hyperscalers), and data provided by industries.

These estimates are already highly informative. However, they need to be supplemented to better understand the full range of environmental impacts associated with the development of AI and to identify relevant mitigation strategies.

To extend existing research on the environmental footprint of AI, the Observatory on AI's Environmental Footprint, led by the AI and Society Institute at ENS, is recruiting several post-docs.

Activities

The objective of the postdoctoral research will be to propose predictive models [Guennebaud & Bugeau, 2024] that allow for the variation of variables such as the rate and speed of digital equipment renewal, energy efficiency gains, the end-of-life management of equipment [Wang et al., 2024], the quantities and types of data required for training and

inference, among others. The scope will also be extended to include dedicated energy production infrastructures and to analyze questions of resilience.

- PhD in Data Science, Computer Science, Applied Mathematics, Electronics, or Industrial Engineering

- Knowledge of the environmental impacts of digital technologies, life cycle analysis, and the functioning of artificial intelligence would be appreciated

Working conditions

The candidate will join the NeS (Digital and Sustainability) team at LaBRI in priority or the SEME team at LISN. Regular travel between LaBRI and LISN will be required.
